The roofing crew will set up from **7:30 a.m. to 8:00 a.m.** and work until dusk, Monday through Saturday. A dumpster, storage container, forklift, and port-potty will be placed in approved, designated areas. All items will be removed after the work in your street is completed.

We have a few recommendations for you **BEFORE** commencing the project:

	Please protect the interior of your unit by taking down any decorations
Indoor	on the walls. Also, nail pops and small cracks are common on the
Decorations	ceilings or walls during the roof replacement project. These are natural
	occurrences during construction and do not reflect the work performed.
Outdoor Furniture	Please remove, store, and/or protect any personal or decorative items
and Decorations	placed on the building's exterior.
Window and	Please remove and store your screens while the work is in progress to
Door Screens	avoid damage to all screens during the shingle removal.
	To avoid damaging outdoor Smart devices such as cameras or Ring
Smart Device	doorbells during the shingle removal, please remove and store them
Security Cameras	while the work is in progress. Once we have completed your unit, you
and	may reinstall them. Please turn off the alarm system while we work
Ring Doorbells	on your building.
	We suggest covering your belongings in the attic with a tarp or an old
Attics	sheet. This will protect them and prevent debris from getting on the
	attic's contents.
	Ring, Google Nest, etc., doorbells, cameras, speakers, and spotlights
Additional Items	are fragile, and we cannot guarantee they will be protected from
	damage.

DURING the project:

If indoor/outdoor items are not removed or left unprotected prior to the start of your building, Lemus Construction will relocate the outdoor items that pose a conflict but will not accept liability for any damage to screens or indoor or outdoor items.

Vehicles	Please remove and relocate your vehicles from the parking spots <i>no later than 7:30 a.m.</i> Please be patient and allow us time to complete each building before putting them back. An ounce of prevention will eliminate any potential damage to your vehicle (s) and allow you to run your errands without obstructions. <i>Lemus Construction will not be responsible for any damage.</i>
Safety	For your safety and the safety of the crew, please refrain from crossing any area where you see TAPED OR CONED OFF AREAS AND ACTIVE CONSTRUCTION. Children & Pets: For everyone's safety, please refrain from having your children play outside of the buildings for the duration of this project. We also suggest keeping your pets away from any construction area.
Project Material	Residents are strictly prohibited from being in or around the following
Dumpster /	areas: project material storage, dumpster, portable toilet, and storage
Storage areas	container. Dumpsters are for the use of construction materials only.

AFTER the project:

Once the roof installation is complete and all crews are no longer working on your building, we suggest that you then engage a contractor to handle all necessary interior repairs including applying "Kilz" to old water stains on your ceilings and walls.
